WHEN PREPARING YOUR PHOTOS, PLEASE REMEMBER:

- All photos must be printed on photographic paper. All photos must have **secure matts/mounting boards (not cardboard)** no larger than 11 x 14". All photos, (except Juniors) must be printed either 8 x 10" or 8 x 12". **With the exception of...** Panorama photos which must be no smaller than 10" on the long side and Square photos which must be 8 x 8". **Juniors'** photos may be 7 x 5" or 6 x 8" with a standard size matt/mounting board. No frames, glass or staples will be accepted. **PHOTOS ARE NOT TO BE GLUED TO MATTS.**
- All photos must be printed on photographic paper and each photo must be clearly marked on the back with Section, Photo Title, Entrant's Name, Address and Sale Price or NFS (prices will not be negotiated on entrant's behalf).

Hint: When Entry Forms are sent prior to photo's keep a copy of the form or entry details so matching details can be written correctly on the back of photo entries.

- If photos are to be returned by mail, a stamped self-addressed envelope must be included.

Important Dates:

All entry forms, payment and posted photos must be received by 5pm, Wednesday 27th March 2019. These should be sent to Michelle Kearney, P.O. Box 391, Goondiwindi, QLD 4390. **No Late Entries will be accepted.**

Hand-delivered photos (**not payment**) can be dropped at Wayne Pratt Photography 8A Moffatt Street, Goondiwindi **by 4pm**, Wednesday 10th April 2019. **Please Note: No entries accepted on day of hanging! Late entries will not be hung.**

Photos should be collected from the Showgrounds on Saturday, 4- May 2019 after **6pm** from the McColl Pavilion. **Photos not collected on Show Saturday** can be collected from the Show Office. Uncollected photos will be destroyed after six months.

Posted photos will be returned provided a stamped self-addressed envelope has been included with the entry.

GST Provisions:

1. All entry fees are GST inclusive. No Invoice will be provided.
2. All prizes are GST exclusive. If you are GST registered and win a cash prize or an acquisition prize, a 10 % GST component will be added to the value of this prize or acquisition.
3. All non registered photographers must provide the organisers with a declaration stating they are not "in business" in order to receive full payment for any prize or sale
